

Role of a Dover District Councillor

"As a councillor you will have many different roles to balance. As the local elected representative you will engage with residents and groups on a wide range of different issues and take on an important community leadership role.

At the council you will contribute to the development of policies and strategies, including budget setting, and you may be involved in scrutinising council decisions or taking decisions on planning or licensing applications."

You are an elected representative for:

Your Ward – c.2,902 electors per councillor

The Dover District Population – 118,100

54,154 residential properties

The Dover District Area is approx. 314 km²

Dover District Council:


32 District Councillors representing 17 Wards

So what happens when you are elected?





Thursday 4 May 2023

If you are at election count you will receive, following the announcement of the result, your welcome pack from a member of the Democratic Services team which will contain key documents to complete for Monday 8 May 2023

Wednesday 10 May 2023

Your term of office will commence on the 4th day following the election (Monday). However, due to the Coronation Bank Holiday this will be delayed to the Wednesday.

You cannot act as a councillor until you have signed the Declaration of Acceptance of Office

Wednesday 10 May 2023 (daytime)

All Councillors to attend Council offices to sign Declaration of Acceptance of Office, collect key card, submit paperwork (including Disclosable Pecuniary Interest form) and have photograph taken for website

Monday 8 May 2023

You will have an email address created (cllr-first.last@dover.gov.uk) by ICT

Council provided ICT device will be made available within the first 14 days

Monday 8 May 2023

The website is updated at the end of the 4th day following the election to show the newly elected district councillors

New Councillor Induction Evening

Thursday 11 May 2023 at 6.00pm

This will be the first opportunity to meet the Corporate Management Team and Monitoring Officer

By no later than Wednesday 17 May 2023

If elected for a political party, you will have formed a "political group" on the Council.

A political group must have a minimum of 2 members. Each group must have a Group Leader and Deputy Leader Annual Council Meeting Wednesday 17 May 2023 at 6.00pm

This will be your first formal meeting as a district councillor.

The meeting will Elect the Leader of the Council (for 4 years), Chairman of the Council (for 1 year), Vice-Chairman of the Council (for 1 year) and Committee seat allocation (for 1 year)

4 Weeks after Annual Council Meeting

You are required to have completed training before taking up your seat for the following committees:

- Planning Committee
- Governance Committee
- Licensing Committee
- •Regulatory Committee



Council, Cabinet & Committee Meetings

All statutory committees must be held in person

Non-statutory committees can be held remotely via Teams

The majority of Council and Committee meetings are held at 6.00pm in the Council Chamber

during the day

Project Advisory
Groups are usually
held during the day via
Teams

Council broadcasts some of its meetings via its website

Agendas are published via the Mod Gov
System through a secure App



Mod Gov System

You will access agendas and minutes through the secure Mod Gov App, except for your first agenda (Annual Council – 17 May 2023)

- Training will be provided
- Saves in excess of £50k per annum in printing and postage
- Instant Delivery of agendas and minutes
- Positive environmental impact due to reducing paper usage
- Agendas can be annotated and indexed on the app

The Leader and Cabinet

Cabinet Composition and Portfolios – Up to 10 members including the Leader & Deputy Leader

Executive Functions under Local Government Act 2000

Executive arrangements from May 2011 were for a strong leader model

Cabinet recommend a budget and Council approves the final budget

Overview & Scrutiny Committee

To achieve accountability and transparency in decision-making

To consider key issues of public interest

Review and scrutinise decisions made by the Executive

To make recommendations to the Executive and Council on policies, budget, performance and service delivery

How does scrutiny work?

Meets approximately 11 times a year

Scrutinises policy and decisions of the Executive and wider issues that affect the Dover District

Examine issues after consideration by the Executive ('Post Decision Scrutiny')

Cabinet Members can be scrutinised by the Overview & Scrutiny Committee

The Constitution


