TOWN AND COUNTRY PLANNING (GENERAL PERMITTED DEVELOPMENT) **ORDER 1995**

WHEREAS Dover District Council of White Cliffs Business Park Dover Kent CT16 3PJ (hereinafter called "the Council") being the local planning authority for its area is satisfied that it is expedient that development of the descriptions set out in Schedule II hereto should not be carried out on the land shown delineated and shaded red on the plan annexed hereto PERHITED and comprising the land described in Schedule I hereto and that it would constitute a threat ORDER 1995, PLANNING PERHISSION to the amenities of their area unless permission therefore is granted by the Council on an application made in that behalf and that the provisions of Article 5(4) of the Town and Country Planning (General Permitted Development) Order 1995 (the "1995 Order") should apply to this Direction.

WITHIN THE MEANING OF ARTICLE 4 (6) OF THE TOWN & COUNTRY PLANNING (GENERAL

COUNCIL CONSIDER NOW THEREFORE the Council, in pursuance of the powers conferred upon it by Article 4(1) of the 1995 Order HEREBY DIRECTS that the permission granted by Class B of Part 4 of Schedule 2 to the 1995 Order set out in Schedule II hereto shall not apply to the land described in Schedule I SUBJECT to the Provisos specified in Schedule II and that this Direction may be cited as the "District of Dover (Dover) Town and Country Planning Direction Number 2 of 2007"

UNDER ARTICLE 4 (1)

THIS DIRECTION is made in pursuance of the provisions of paragraph 5(4) of the 1995 Order and shall remain in force until the 9th day of June 2008 (being six months from the date of this Direction) and will then expire unless it has been approved by the Secretary of COMMUNITIES AND LOCAL GOVERNMENT State before that date.

All that land shown shaded red on the plan number 266/07 annexed hereto and comprising approximately 14.85 hectares of land on the South side of Coombe Road, Dover in the County of Kent.

SCHEDULE II

(Part 4 of Schedule 2 to the 1995 Order)

The use of any land for any purpose for not more than 28 days in total in any calendar year, of which not more than 14 days in total may be for the purposes referred to in paragraph B2, and the provision on the land of any moveable structure for the purposes of the permitted use (Class B).

NB. Paragraph B2 reads:

The purposes mentioned in Class B above are -

- (a) The holding of a market;
- (b) Motor car and motorcycle racing including trials of speed, and practising for these activities.

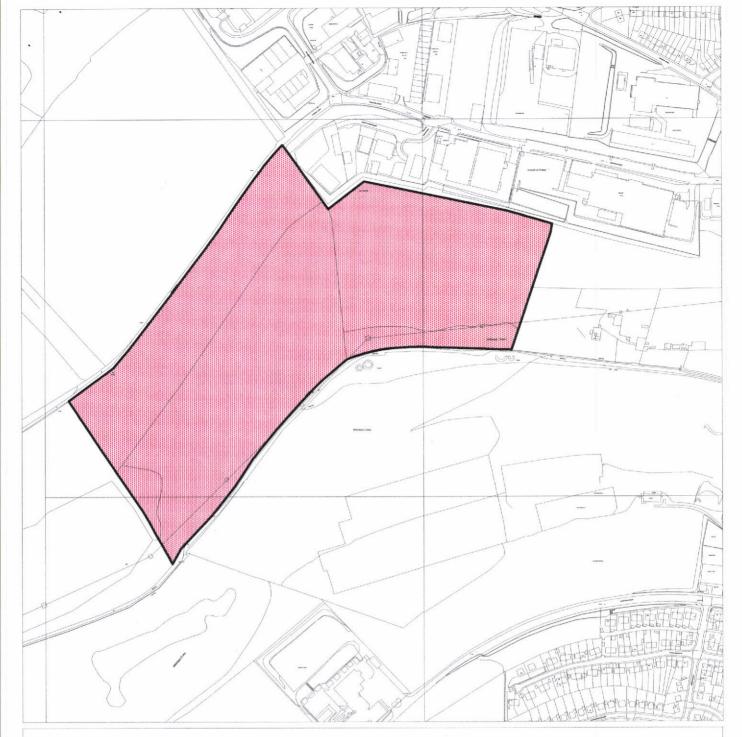
