### TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDERS 1973 TO 1974

WHEREAS The Kent County Council being the appropriate local planning authority within the meaning of article 4 of the Town and Country Planning General Development Order 1973 are of the opinion that development of the description(s) set out in the Schedule hereto should not be carried out on land at Lydden Race Circuit in the Districts of Canterbury and Dover being the land shown coloured pink on the plan annexed hereto unless permission therefore is granted on application made under the Town and Country Planning General Development Order 1973.

AND WHEREAS the Council are further of the opinion that development of the said description would constitute a threat to the amenities of the area and that the provisions of paragraph 3(b) of the said article 4 should apply to this direction.

NOW THEREFORE the said Council in pursuance of the powers conferred upon them by the said article 4 hereby direct that the permission granted by article 3 of the Town and Country Planning General Development Order 1973 shall not apply to development on the said land of the description(s) set out in the Schedule hereto.

THIS DIRECTION is made in pursuance of the provisions of paragraph 3(b) of the said article 4 and shall remain in force until Twentieth December 1976 (being six months from the date of this direction) and will then expire unless it has been approved by the Secretary of State for the Environment before that date.

NOTICE IS HEREBY GIVEN that The Kent County Council in pursuance of the powers conferred upon it by Article 4 of the Town and Country Planning General Development Order, 1973, has made a Direction directing that the permission granted by Article 3 of the said Order shall not apply to land at Lydden Race Circuit in the Districts of Canterbury and Dover insofar as development, consisting of the use of the land for the purposes of holding a market on not more than 14 days in total in any calendar year, and the erection or placing of moveable structures on the land for the purpose of that use being development comprised within paragraph 2 of Class IV of Part 1 of the First Schedule to the Town and Country Planning General Development Order, 1973, is concerned. The effect of the Direction is that planning permission must be obtained before any of the afore-mentioned development is carried out on the said land.

The provisions of Article 4(3)(b) of the said Order apply and this Direction comes into force upon the date of the service of this notice upon you. It will remain in force for six months and will then expire unless before the termination of the said six months, it has been approved by the Secretary of State for the Environment. You will be notified if the Secretary of State approves or disallows the direction. A copy of the Direction is forwarded herewith.
