TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER, 1963.

WHEREAS

(1) the County Council of the Administrative County of Kent (hereinafter referred to as "the County Council") is the Local Planning Authority for the said County for the purposes of the Town and Country Planning Act, 1962;

(2) the County Council is satisfied that it is expedient in the interests of the amenities of the area that development of the description set out in the Schedule hereto shall not take place on land known as part 0.S. 316, Poulton Farm, Hougham Without in the Rural District of Dover such land being shown coloured pink on the plan annexed hereto (hereinafter referred to as "the pink land") unless permission therefore is granted on an application in that behalf.

N 0 W THEREFORE the County Council in pursuance of the powers conferred upon it by Article 4 of the Town and Country Planning General Development Order 1963 and of all other powers enabling it in that behalf HEREBY DIRECTS that the permission granted by Article 3 of the said Order of 1963 shall not apply to development of the description specified in the Schedule hereto in on over or under the pink land or any part or parts thereof.

THIS DIRECTION may be cited as the Kent County Council (Rural District of Dover) Town and Country Planning Direction No. 1, 1967.


