# **Dover Fastrack Newsletter #19**

### Section 1 – Honeywood Parkway over A2



Image above shows view towards bridge and embankment.

In September, we constructed the concrete bridge diaphragms. These are situated either side of the bridge deck that was poured in August. Upcoming works relating to the bridge construction are on the A2 itself where we need to complete works to the street lighting and the barriers in the centre of the carriageway.

In Section 1b North we have been constructing drainage in the area towards section 1a. We are also monitoring the settlement of the embankment.

In Section 1a, we have continued to construct the new road and surrounding drainage, including installing kerbs and subbase. We have also constructed two Deep Bore Soakaways. This is a drainage system that is used where the geology is impermeable, such as the clay and chalk ground found on site. Image below: drainage construction in Section 1a



In Section 1b South, work has continued to construct the road leading onto Honeywood Parkway including the construction of drainage and earthworks. We have also continued the construction of the retaining wall.

## Looking Ahead

In the coming month, we will continue with the activities described overleaf. We will also be pouring the bridge parapets and installing a new low voltage street light cable.

#### Section 2 - B&Q Roundabout to Dover Road and the Dover Road Tie-In

In September, work has continued to seed and plant across Section 2. Landscapers have been working throughout the section to prepare the ground for planting. This will continue in October.

#### **Traffic Management**

#### Section 1 Tesco Roundabout to Whitfield

Narrow lanes traffic management remains in place with reduced speed limit installed on the A2 between A256 Whitfield Interchange and A256 Whitfield Roundabout both east and westbound until November 2023.

Emergency Free Breakdown Recovery is available within the narrow lane section on the A2 via a dedicated 24hr Traffic Safety and Control Officer number on **07974 617 256**.

#### Noise, Vibration and Dust monitoring

Vibration monitoring is set up in Section 1 North side of the A2 by Newlands and is regularly monitored by Colas. Noise monitoring is also being carried out on Dover Road and in Section 1b North by Newlands. The installation of noise, ground, and vibration plates to monitor any earth movement helps us to ensure that we are staying below limits and are causing as little impact as we can.
