# **Dover Fastrack Newsletter #20**

#### Section 1 – Honeywood Parkway over A2

In October, we constructed the concrete bridge parapets. These are situated on either edge of the bridge and are the foundations for the vehicle and pedestrian barriers that will be constructed later in the year.

In Section 1b North, we have continued to construct the kerbs for the new section of road. We have also begun to construct new acoustic barriers along the north side of the A2. These barriers provide some protection for surrounding residents from road traffic noise.

In Section 1b South, a low voltage street lighting diversion has been carried out to allow us to continue works in the section. Waterproofing to the bridge diaphragm has also been completed. Preparation has commenced the for construction of the coping units for the retaining wall.

In Section 1a, we have constructed the drainage for the new road including two deep bore soakaways and a bio-retention pond.

## Looking Ahead

In November, we are sharing road space with National Highways to complete works to the street lighting and VRS (vehicle restraint system). These are the barriers in the centre of the carriageway. National Highways will be carrying out resurfacing works during this period. In section 1a & 1b North we will be making preparations to lay the tarmac over the subbase we laid in September and October.

### Section 2 - B&Q Roundabout to Dover Road and the Dover Road Tie-In

In Section 2 we have been carrying out topsoiling of the verges and grass areas. We have also carried out seeding to these areas. These works will continue into November.

#### **Traffic Management**

#### Section 1 Tesco Roundabout to Whitfield

Narrow lanes traffic management remains in place with reduced speed limit installed on the A2 between A256 Whitfield Interchange and A256 Whitfield Roundabout both east and westbound until November 2023.

Emergency Free Breakdown Recovery is available within the narrow lane section on the A2 via a dedicated 24hr Traffic Safety and Control Officer number on **07974 617 256**.

#### Noise, Vibration and Dust monitoring

Vibration monitoring is set up in Section 1 North side of the A2 by Newlands and is regularly monitored by Colas. Noise monitoring is also being carried out on Dover Road and in Section 1b North by Newlands. The installation of noise, ground, and vibration plates to monitor any earth movement helps us to ensure that we are staying below limits and are causing as little impact as we can.
