Notice is hereby given that KENT COUNTY COUNCIL intend to make the above Order under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act:

If made the effect of the Order will be to further amend Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) Order 2005 as follows:

PAY BY PHONE PARKING

Dover

The time limited residents parking bays in Coombe Valley Road, Coombe Close, Lambton Road and MacDonald Road will become 'Pay by Phone' parking places. The conditions for residents parking permit holders will remain unchanged. Non-residents will lose the two hours free parking and will be required to pay £2 for 1 hour or £4 for two hours parking between 8am and 6pm on Mondays to Saturdays under the proposed Pay by Phone parking scheme.

DISABLED PERSONS VEHICLE PARKING PLACES

Parking places for disabled persons vehicles will be provided in the following locations -

Dover

across the frontages of 7 Beaufoy Road, 28 Beaufoy Terrace, 18 and 119 Buckland Avenue, 35 Douglas Road, 1-7 Godwyne Close, adjacent to Unit 1 Granville Street, across the frontages of 21 Pilgrims Way and 32 Squires Way.

Aycliffe

Opposite 31 Kings Ropewalk, across the frontages of 104 St. David's Avenue and adjacent 40 St. George's Crescent.

River

across the frontage of 161 Lewisham Road

Dea

Across the frontages of 21 Robert Street and 104 and 132 Stockdale Gardens

Eastry

Across the frontage of 5 Gore Close, Gore Lane.

Wingham

across the frontage of 4 Orchard Close

Disabled persons vehicle parking places in the following locations are no longer required and will be removed –

THE KENT COUNTY COUNCIL (VARIOUS ROADS, DOVER DISTRICT) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (AMENDMENT No. 102) ORDER 2023

The Kent County Council, in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49, 53 and 124 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

A. The Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) Order 2005 Shall have effect as though:

In the Articles of the Order

INTERPRETATION

'Pay and Display' means a system of payment for parking of motor vehicles used at car parks where prepaid tickets must be obtained and be displayed in the appropriate manner within the vehicle; such tickets to be non-transferrable to any other vehicle or car park;

'Pay by phone' and "telephone payment parking system" means a parking payment system enabling payment for parking to be made by the use of a mobile phone through a system operated, administered and maintained by Cobalt Telephone Technologies Ltd (the Service Provider) and known as 'RingGo'.

Each participating parking place will be assigned its own unique identifying number, the 'Location Identification Number'. Customers using this system are exempt from the requirement to display a pay and display ticket or permit. A service fee will be added to the parking fee except in parking places where Pay by phone is the only form of payment available.

Article 24 of the Order shall be deleted and replaced with

24. Each area on a highway comprising the lengths of carriageway described in Schedules 3, 3.01, 3.02, 3.21, 5.2 and 5.21 to this Order and, unless otherwise so described, bounded on one side of that length by the edge of the carriageway and having a width throughout of not less than 1.8 metres, is designated as a shared parking place.

The following shall be added as Article 39A

- 39A. SAVE as provided in Part H of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or with the permission of a parking attendant, cause or permit any vehicle to wait during the chargeable hours in a charged parking place described in Schedule to this Order 5.21,
 - (a) unless it is a vehicle of a class appropriate to that parking place described in the Schedule and
 - (b) unless the parking charge has been paid using the telephone payment parking system, or
 - (c) it is a vehicle which is displaying in the relevant position:-
 - (i) A valid Residents' Parking Permit issued in accordance with Park K of this Order; or
 - (ii) A valid Visitors' Parking Permit validated in respect of that vehicle for the Zone in which that Parking Place is situated.

COOMBE CLOSE On both sides

from a point 10 metres north west of the junction with Coombe Valley Road north westwards for a distance of 10 metres

from a point 25 metres south west of the centreline of Edgar Road south westwards to a point 10 metres north east of the entrance to the builder's merchants

from a point 10 metres south west of the entrance to the builder's merchants south westwards to a point 50 metres north east of the centreline of Primrose Road

from a point 10 metres south west of the centreline of Primrose Road south westwards to a point 45 metres south west of the centreline of Primrose Road
