Notice is hereby given that KENT COUNTY COUNCIL intend to make the above Order under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act:

If made the effect of the Order will be to further amend Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) Order 2005 as follows :

PROHIBITION OF WAITING (AT ANY TIME)

<u>Dover</u>

Waiting to be prohibited at all times (Double yellow lines)

WALTER HAMMOND CLOSE - On all sides for the entire length.

DISABLED PERSONS VEHICLE PARKING PLACES

Parking places for disabled persons vehicles will be provided in the following locations

<u>Dover</u>

2 Brookfield Avenue, Dover (across frontage of No.8 Brookfield Avenue); 36 Kings Ropewalk, Aycliff, Dover (opposite no 32/33 Kings Ropewalk); across the frontage of 27 Chevalier Road, Dover.

Deal

91 Mongeham Road, Deal (across the frontage of 94 Mongeham Road), and across the frontage of 34 Liverpool Road, Walmer.

<u>Aylesham.</u>

Across the frontage of 12 Sycamore Avenue, Aylesham.

Disabled persons vehicle parking places in the following locations in Dover are no longer required and will be removed –

110 New Street, Ash; 41 Ark Lane, Deal; 1 Athol Terrace, Dover; 59 Napier Road, Dover; 2 St. Johns Road, Dover; 36 Middle Deal Road. Deal; 65 Dover Road, Sandwich.
