Budget and Council Tax 2008-09

In order to provide its services KCC receives a variety of grants from central government. However, these are not enough to meet our budget demands, which have increased by £60.1 million (m), so we need to increase council tax.

The money KCC receives from the Government in business rates and general grant has increased by £8.6m or 3.4% in 2008-09, compared to an average county increase of 5.3%.

We set our council tax as low as possible while keeping good quality services. KCC is making savings of £24.8m across the council's services. We are increasing income by £2.4m in 2008-09 through, for example, improved returns on treasury management, and increased income from Commercial Services.

All of this helps to keep the increase in council tax at 3.9%.

Comprehensive Performance Assessment (CPA)

The Audit Commission's annual Comprehensive Performance Assessment measures how well councils deliver services to local people and communities. KCC has been rated as a top performing council every year since CPA first began in 2002. We have been awarded four stars again in February 2008.



In December 2007, KCC was given the highest award, level four, for its use of resources for the second year running. The award rates public services on how well they deliver value for money services.

County Council Services

The council tax you pay helps us to continue running our services at the best possible standards. Here are just some of the services your money contributes to:

- **Education** - Supporting 453 primary schools; 97 secondary schools; 24 special schools and one nursery.
- **Adult Social Services** - Supporting more than 30,000 older people, disabled people and people with mental health problems to live in their own homes, and more than 6,500 people to live in permanent residential or nursing care.
- **Environment, Highways and Waste** - Maintaining 20 country parks; 5,200 miles of county roads; 4,300 miles of public rights of way; 300 miles of cycle routes; 2,700 bridges; and 119,000 street lights. Disposal of some 800,000 tonnes of household waste.
- **Communities** - Handling 1.2m calls to the contact centre and 8.1m library visits; engaging with 40,000 young people; improving the skills and confidence of 38,000 adult learners; and celebrating 5,300 civil marriages and other ceremonies.

KCC's long-term goals

- Continued improvements in services while keeping council tax down

Our main service pressures

- Social Care - demographic pressures of £7.8m to cope with increasing numbers and longer life expectancy of the very elderly and people with a disability. This enables us to maintain the existing assessment criteria and provide preventative support to more people. Inflation pressures add a further £8.4m.
- Children's Services - demographic, legislation and inflation pressures across a range of services (Early Years, Social Services, implementing Care Matters, fostering and adoption), totalling £6.9m.
- Highways - an injection of £5m per annum to help improve the maintenance and condition of roads and pavements. This is in addition to inflation totalling £1.2m for highways maintenance.
- Capital investment - to support our services and provide additional local infrastructure, including supporting the new communities being built in Kent. Revenue costs of additional borrowing to support that investment are projected to rise by £4.3m in 2008-09.
- Waste disposal - increasing costs of disposal and level of landfill tax. Volumes, price rises and tax increases amount to £4.5m.
- Providing more free or low-cost public transport for 11-16 year olds through extending the piloted Freedom Pass scheme costing £4.0m.

The council tax you pay for KCC services has increased by 3.9% - an extra 72p a week for a Band D household.

Your total bill will be more than shown below, as it will also include contributions to your local borough, city or district council, the police and fire authorities and (in many areas) a parish or town council.

Can you help reduce the £64.6m it costs in a single year to get rid of Kent's household waste?

It will cost Kent residents £64.6m for the county council to manage the disposal of some 812,000 tonnes of household waste next year – and that does not include the cost of collecting it. You can help manage the cost by reducing the amount of waste you produce at home.

Each household in Kent generates nearly one and a half tonnes of household waste a year. If every Kent resident reduced their waste by 5% it would save a total of £3.8m a year.

Could you be entitled to a Council Tax rebate?

Whilst most council tax payers have to pay the full bill, KCC is working in partnership with the borough, city and district councils to help everyone who is entitled to a council tax rebate to claim it.

- Over the past three years Kent Benefits Partnership has reduced council tax bills for Kent residents by more than three million pounds.
- If your household has less than £16,000 in savings, and is on a low income then you too may qualify to get some help with your council tax bill.
