## GENERAL INFORMATION

Charges in the Dover District Council Car Parks in Dover, Deal and Sandwich apply between 9.00am to 6.00pm, Monday to Saturday including Bank Holidays, with the exception of Beach Street Car Park in Deal, Camden Crescent Car Park in Dover and The Quay Car Park in Sandwich, where charges apply Monday to Sunday including Bank Holidays. Charges also apply on a Sunday to the pay and display parking bays along the seafront at Dover and Beach Street in Deal. Parking is free from 6.00pm to 9.00am. Parking tickets can be purchased during the free period and are timed to commence from 9.00am.

**Disabled Parking**

Vehicles displaying a valid Disabled Badge and time clock, set at arrival time, may park for up to three hours (or maximum stay time permitted if less than three hours) free of charge in Dover District Council Car Parks. Additional parking can be purchased from the ticket machine if required on arrival.

**Car Park Security**

Closed Circuit Television (CCTV) has been introduced in Dover, Deal and Sandwich and although proving successful in reducing the level of crime, no security system can guarantee total protection. Please ensure on leaving your vehicle that it is locked and all valuables are out of sight.

**Dogs in Vehicles**

You are advised not to leave dogs in vehicles, unaccompanied, during hot weather. It is the policy of this Council to report incidents to the R.S.P.C.A.

## CONDITIONS OF USE

1. The permit is valid for a twelve-month, six-month or three-month period, from the first day of the month in which the application is made, except in the case of renewals.
2. A completed application form and fee to be presented at the time of application, or details of company if wishing to pay by invoice.
3. Permits are only available for motor vehicles and light vans not exceeding 5.55m long, 2.5m high or 1.2m wide, excluding wing mirrors.
4. Permits are only valid on the vehicle specified.
5. When the permit is in use, it must be clearly displayed.
6. The permit can only be replaced in the case of loss, destruction, or through a change of vehicle for which there is an administrative charge of £5.
7. Any contravention of the conditions of the Traffic Order, (which is available for inspection during working hours at The Council's local offices) will render the permit invalid and the permit will be with drawn.
8. The purchase of a permit does not guarantee the availability of a parking space.
9. If two registration numbers appear on the one permit, it must be safely secured to the windscreen of whichever vehicle is being used, as the permit is only valid for use in one vehicle at any given time. Any Penalty Charge Notices incurred for non-display cannot be cancelled.
10. Refunds will be given on surrender of a permit at a rate of one twelfth of the annual cost for each complete calendar month remaining.
