

Scrap Metal Act 2013

Application for a Scrap Metal Collectors Licence

Only complete this form if:

- 1. You are carrying on a business as a mobile collector in the local authorities area and:
- 2. A person who carries on a business as a scrap metal dealer otherwise than at a site and;
- 3. Regularly engages in collecting waste materials and old, broken, worn out or defaced articles by means of visits from door to door or;
- 4. A person who is buying or selling scrap metal

A mobile collector's licence will cover any employees working for that business. If they are not employed directly by that mobile collector's business and are self-employed, they will need their own collector's licence even if they are collecting metal from the same van as a person who has a mobile collectors licence.

You cannot hold both a site licence and a collector's licence in the same local authority area.

You must not complete this form if you are acting as a motor salvage operator

A motor salvage operator is;

- (a) Wholly or partly in recovering salvageable parts from motor vehicle for re-use or sale and subsequently selling or otherwise disposing of the rest of the vehicle for scrap,
- (b) Wholly or mainly in buying written-off vehicles and subsequently repairing and reselling them,
- (c) Wholly or mainly in buying or selling motor vehicles in which are to be subject (whether immediately or on a subsequent re-sale) of any of the activities mentioned in paragraphs (a) and (b) or,
- (d) Wholly or mainly in activities falling within paragraphs (b) and (c)

If any of the above applies you will need to apply for a 'Site' Licence.
