Dear resident,

I am contacting you to let you know the Port of Dover and Eurotunnel are forecasting a busy crossing period for tourist traffic, as people prepare to go away over the summer holidays.

To help keep traffic flowing through Dover, and reduce congestion on local roads, the Kent and Medway Resilience Forum (KMRF) has agreed to deploy Operation Brock on the M20.

Although I understand the decision to use Brock at busy times is not always popular, the contraflow system reduces the chance of needing to close the Roundhill Tunnel due to queuing lorries, and this helps to minimise disruption in Folkestone and Dover during the busiest travel days. The contraflow will be deployed on the M20 London-bound carriageway between Junctions 8 and 9 overnight on Monday 13th July, meaning the contraflow will be in place from Tuesday 14th July.

This will allow lorries to be held on the coastbound carriageway should the Dover TAP queuing system on the A20 fill up.

The barrier will remain in place until Monday 24th August.

Similar to the May half term holidays, the KMRF will also have Lydden Hill Race Circuit available at particularly busy times as a last resort contingency site for passenger traffic. This site builds on existing contingency plans that are designed to keep Kent's roads moving.

The KMRF has taken the decision to have this site ready at various times during the peak summer getaway season. The site provides authorities with a safe offroad area that passenger traffic could temporarily use enroute to Dover. The site's actual use is reserved for an extreme scenario when it would be used help to maintain fluidity in Kent.

As the strategic lead for border disruption for the KMRF, I want to reassure you that everyone involved in managing traffic at this busy time is fully focussed on keeping traffic moving and making sure communities in and around Dover and Folkestone safe.

However, should any disruption occur due to delays at the Port of Dover or Eurotunnel, we want to do all we can to support you through this by offering as much help and advice as possible.
