### Terms and conditions

#### 1. Organiser

1.1. This competition is being organised by iChoosr Ltd.

#### 2. Eligibility

6.4. The prize will be issued in the form of a cheque, to the value of the winner's personal offer from the winning supplier up to the value of £1,135.
