WHEREAS the Council of the District of Dover being the appropriate local planning authority within the meaning of Article 4 of the Town and Country Planning General Development Order 1988<sup>(As Amended)</sup> are satisfied that it is expedient that development of the description set out in the Schedule hereto should not be carried out on land within the Parish of Denton with Wootton situate on the south western side of the A2 Highway, Denton with Wootton in the County of Kent and comprising 81 acres or thereabouts being the area of land shown edged in red on plan number 184/90 annexed hereto unless permission therefor is granted on application made under Part III of the Town and Country Planning Act 1970

NOW THEREFORE the said Council in pursuance of the powers conferred upon them by the said Article 4 hereby direct that the permission granted by Article 3 of the Town and Country Planning General Development Order 1988<sup>(As Amended)</sup> of the description set out in the Schedule hereto shall not apply to development on the said land

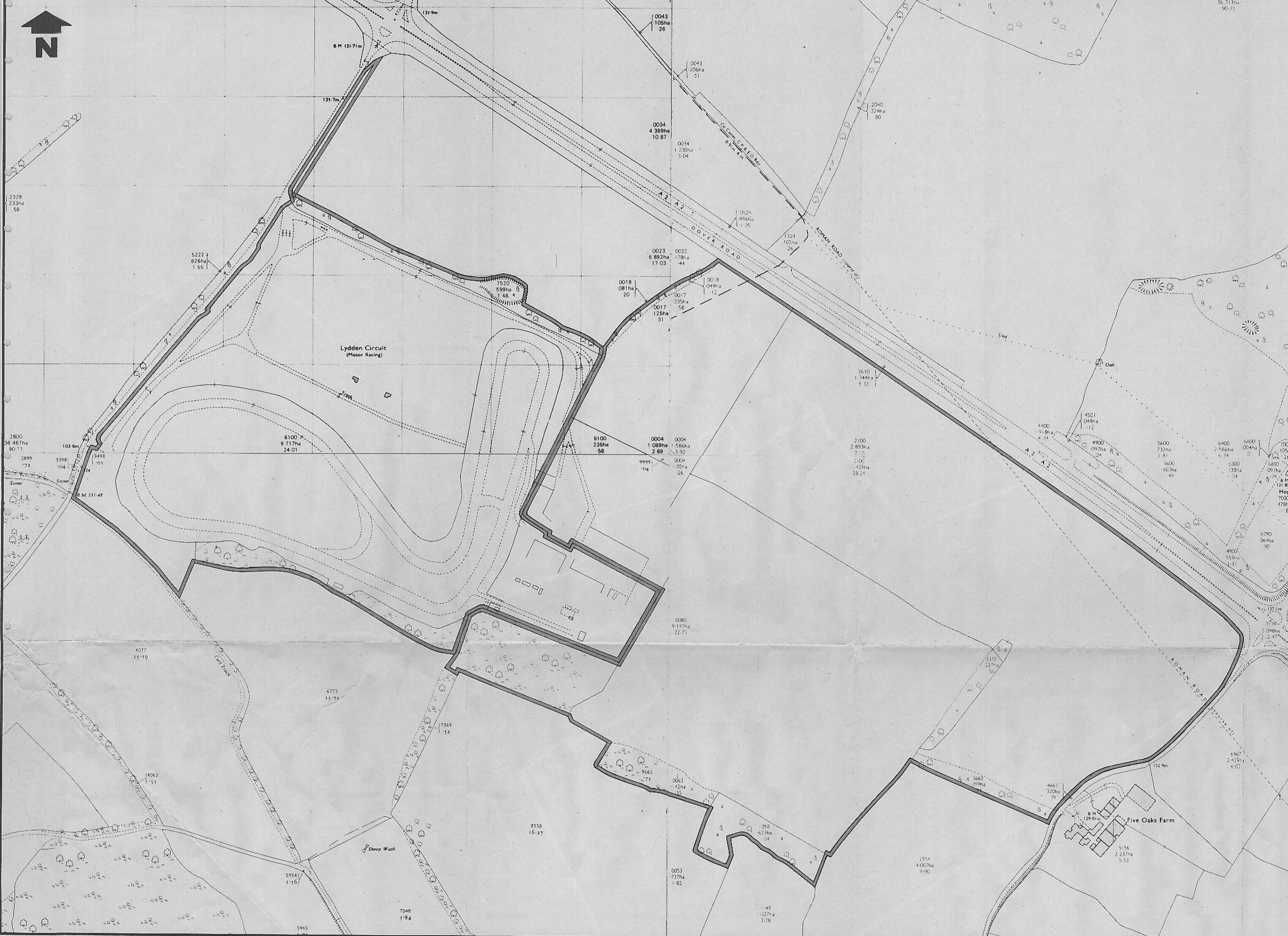

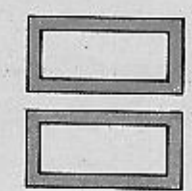
