Reduce in height to approximately 6 metres and cut back overhanging foliage to the fence line of three Sycamores (T1, T2 and T3), all the subject of tree Preservation Order No 5 of 2003. All the other trees in this cluster (G1) have been reduced, however these three were omitted from the previous application due to an unresolved boundary dispute, leaving them vulnerable to winds they would previously have been sheltered from. Location: Parcel of land adjoining 14 Bevan close which is owned by Mr&Mrs Warman. The ownership of trees T1,T2 and T3 is unclear, however both possible owners are in agreement with the proposed work. There is also confusion on the DDC website where there are multiple TPO?s covering the same trees, with one TPO showing that these trees are only protected for 5 years after the first occupation of the houses in Bevan Close, which would have expired several years ago.
