First floor remove bedroom partition, form new door opening to access bedroom. External works include replace French doors to kitchen and remove jetty porch to south elevations. Replacement glazing to loggia, timber frame and structure repairs including replacement render panels to east elevation. Remove timber railings from west elevation and insert external lighting to courtyard. Lodge internal alterations include form new door to kitchen infilling existing opening, replace plaster finishes to lounge. External works include replace window with door to north elevation. Insert new window, door and side light and projecting bay window. Remove porch and insert new canopy all to south elevation.
