## **FITNESS FIELDS, WHITFIELD**

Kent County Council, as traffic authority, propose to make the above named Order the effect of which will be to change existing or introduce new parking or waiting restrictions as follows:

### **Fitness Fields**

It is proposed waiting will be prohibited at all times (DYL) on both sides for the entire length of Fitness Fields.
