## In the District of Dover

### **THE DOVER DISTRICT COUNCIL (OFF STREET PARKING PLACES) ORDER 2020 AMENDMENT NO.4 Road Traffic Regulation Act 1984**

Notice is given that DOVER DISTRICT COUNCIL under sections 1(1), 2 (1) to (3), 3 (2), 4 (1) and (2), 32 (1), 35 (1), 44, 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and all other enabling powers, after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby proposes to make the following order:-

1. Two additional disabled bays be added to Pencester Road car park and restrictions be imposed on those spaces in accordance with Schedule 3 of the Order 'SURFACE CAR PARKS WHERE CHARGES ARE IMPOSED DISABLED PERSONS VEHICLES/INVALID CARRIAGES'.
2. To add a new paragraph 15 to Schedule 9 of the Order "PERMITS" to create 4 spaces for use solely by staff permit holders.
3. To amend the Order to update Schedule 2 "SURFACE CAR PARKS WHERE CHARGES ARE IMPOSED MOTOR VEHICLES" to increase the prices as set out in the documents on deposit.

## **ROAD TRAFFIC REGULATION ACT 1984**

DOVER DISTRICT COUNCIL, acting as the Local Traffic Authority and in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49, 53, 122 and 124 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby proposes make the following Order:-

### **Revocations, Modifications and Amendments**

In this Order the expression "Order of 2020" means "The Dover District Council (Off Street Parking Places) Order 2020". The Order of 2020 shall have effect as though:

1. Two additional disabled bays be added to Pencester Road car park and restrictions be imposed in accordance with Schedule 3 of the Order 'SURFACE CAR PARKS WHERE CHARGES ARE IMPOSED DISABLED PERSONS VEHICLES/INVALID CARRIAGES'. The two additional bays are shown on the plan annexed to this Order.
2. To add a new paragraph 15 to Schedule 9 of the Order "PERMITS" to create 4 spaces for use solely by staff permit holders:

Business – Kearsney Abbey Staff and Café Car Park

- a. Class of Vehicles - Motor vehicles/staff and permit holders, not exceeding the sizes set out in Article 3.
  - b. Position in which vehicle In the Parking Bays indicated by white lines and/or other. Suitable notice or markings.
  - c. Eligibility: Staff and/or permit holders only.
  - d. Hours of Validity: As per café opening times/signage.
  - e. Days of Validity: All days
  - f. Valid in the following: Kearsney Abbey Staff and Café car park only parking places.
3. To amend the Order to update Schedule 2 "SURFACE CAR PARKS WHERE CHARGES ARE IMPOSED MOTOR VEHICLES" to increase the prices as shown in the table below:
